Progressives Have Had Their Way ~ Time to Throw Their Faulty Logic Into the Dustbin of History!

What happened to the Framers’ Plan for a limited government? What clauses of the Framers’ Constitution did the Progressives so dramatically abuse to take America in a political direction she was never intended to go? This seminar provides insight to the questions being asked today.

General Welfare Clause: Never intended to be a grant of power but intended to LIMIT the power of TAXATION! Used by the Framers in the collective sense—meaning what Congress did under the general welfare clause must be done for the good of ALL the people—at the same snapshot in time—irrespective of age, gender, political affiliation or economical status. What changed? WHO were the key agents of change?

Commerce Clause: Its original intent aimed only at keeping the States from treating one another as though a foreign nation. It was never meant to expand Congressional or Executive power at will. Yet so many myths abound regarding the original purpose of the Commerce Clause. The Progressives have done a most complete job in propagating the notion that “if it moves tax it, if it keeps moving regulate it; and... if it stops moving, subsidize it.”

Necessary and Proper Clause: Otherwise known as the “elastic clause,” its original intent was to give the general government the *necessary* authority for carrying forth the enumerated powers of the Constitution. What ill conceived notions about this clause turned its limiting character into an all-enabling one thereby authorizing Washington, DC to do anything it wished to do?

Supremacy Clause: What is the role and function of the Constitution for the United States of America? What is meant by the Supremacy Clause? Isn't God Supreme? Does the Supremacy Clause raise man-centered law above the laws given by the Creator of the Universe? Just what were the Framers thinking by including this verbiage as part of the text of the Constitution?
